

Executive Summary

or more than one year, the Border Trade Alliance (BTA) has conducted an exhaustive, grass-roots, comprehensive analysis of the infrastructure improvements required by communities, both large and small, along the southwest border of the United States. This unprecedented, borderwide effort conducted by this non-partisan trade group has generated specific, ready-to-go, job-producing projects. To accomplish this, the BTA has solicited the advice, planning and input of hundreds of business leaders, local government officials, trade groups, academic experts, representatives from the governor's offices of the four southwest border states and economic development officials in 14 southwest border communities from Brownsville, Texas to San Diego, California. The cooperative effort of these individuals has produced the most comprehensive infrastructure project review in the history of the U.S.-Mexico border region. The BTA infrastructure projects described in the following pages address the most critical capital and human infrastructure needs in seven priority categories:

- 1. ports of entry,
- 2. airports,
- 3. education/technology transfer,
- 4. environment/water and sewer,
- 5. health,
- 6. housing, and
- 7. surface transportation.

Each project in each community in each of the infrastructure categories has been identified by a description that includes:


- 1. a brief project summary,
- 2. a proposed funding level to complete the project,
- 3. an estimate of when each project can be initiated,
- 4. federal agency interest and/or support, and
- 5. the estimated job creation impact of each project.


As a prerequisite for inclusion in the BTA package, submitted plans had to be complete or in the final stages of completion and ready for initiation within 60-90 days of receipt of funding. Although the BTA infrastructure improvement initiative was under way more than eight months before the election of President Bill Clinton in November 1992, the BTA plan is consistent with the goals, objectives and criteria he set forth for the infrastructure component of his economic plan that was announced on February 17, 1993. In short, the Border Trade Alliance was at the cutting edge of the national movement for comprehensive, project-specific infrastructure improvement in the United States and was developing a borderwide package well before infrastructure improvement became government policy. The BTA is proud of its foresight and its collaborative effort within the southwest border communities to develop this historic borderwide infrastructure action plan. Although the BTA infrastructure report was prepared for the federal government, projects may be suitable for public and private funding.

THE U.S.-MEXICO BORDER


U.S. - Mexico Border Facts

- The border is approximately 2,000 miles (3,200 kilometers) long.
- The border region encompasses 240,000 square miles, an areal almost equal to the combined areas of Ohio, Indiana, Illinois, Michigan and Wisconsin.
- From 1980 to 1990, the international population in this region has gone from 5.936 million to 9.535 million, an increase of about 60 percent.
- Average per capita income for U.S.-Mexico border residents is \$12,845 and 20.7 percent of the region's population falls within U.S. poverty level guidelines.
- The high school drop out rate for students in U.S.-Mexico border communities is 40.9 percent.
- The infant mortality rate in U.S.-Mexico border communities is 9.7 percent.

The Port of Harlingen, a barge terminal located nine miles from the Mexican border, will complete the engineering necessary to rebuild its two main docks within the next 90 days. These docks, both built in the 1950s, have considerable deterioration to the extent that one is no longer usable.

As trade withe Mexico increases, the Port of Harlingen must rebuild these docks, construct new mooring areas and install state-of-the-art cargo handling equipment and facilities. Recently completed trade and revenue studies indicate that, once completed, the new facilities will have the effect of doubling the Port's annual payroll, tariff and tonnage.

It also supplies the Fruit of the Loom Plant, which employs 1,700 people, with two million gallons of processed water per day. Fruit of the Loom has requested that the treatment plant's capacity be expanded by 500,000 gallons per day. Two other textile mills have indicated their interest in moving to the area if the treatment plant is upgraded.

Harlingen is the only community in Texas that has an agreement with Mexico to fly emergency medical helicopters into the country to evacuate injured maquiladora personnel. The medical helicopter will provide rapid response to major accident scenes in Mexico and South Texas. This program is a critical component in meeting the health care needs of a growing community. Initial start-up costs include purchasing a new helicopter, constructing a heliport, hiring personnel and operating expenses.




